Assumption of Risk

LIABILITY RELEASE, WAIVER DISCHARGE AND COVENANT NOT TO SUE

I, the parent or legal guardian of the student listed on this form; desire to permit the student to participate in the EXALT! Youth Conference ("Activity"), to be held at Maritime Christian College and Canoe Cove Christian Camp. I understand that all students are expected to abide by the Program rules and be directly responsible to their youth leader. The Youth leader from my church assumes responsibility for discipline at the Program and, if necessary, may, because of misconduct or disobedience, require a student to leave. In such instance, I will assume full responsibility for returning the student home. Knowing the dangers, hazards, and risks of such activities, and in consideration of being permitted to participate in the Activity, on behalf of Student, Student's family, heirs, and personal representative(s), Student and parent or legal guardian agree to assume all the risks and responsibilities surrounding Student's participation in the Activity, the transportation, and in any independent research or activities undertaken as an adjunct thereto, and in advance release, waive, forever discharge, and covenant not to sue Maritime Christian College and Canoe Cove Christian Camp, the Board of Trustees and its officers, agents, employees, and any student acting as employees (hereafter called the "Releasees"), from and against any and all liability for any harm, injury, damage, claims, demands, actions, causes of actions, costs, and expenses of any nature that Student may have or that may hereafter accrue to Student, arising out of or related to any loss, damage, or injury, including but not limited to suffering and death, that may be sustained by Student or by any property belonging to Student, whether caused by the willful and/or gross negligence or carelessness of the Releasees, or otherwise, while in, on, upon, or in transit to or from the premises where the Activity, or any adjunct to the Activity, occurs or is being conducted. Student and parent or legal guardian understand and agree that Releasees do not have medical personnel available at the location of the Activity or on the campus. Student and parent or legal guardian understand and agree that Releasees are granted permission to authorize emergency medical treatment, if necessary, and that such action by Releasees shall be subject to the terms of this Agreement. Student and parent or legal guardian understand and agree that Releasees assume no responsibility for any injury or damage which might arise out of or in connection with such authorized emergency medical treatment. Further, Releasees shall not be responsible or liable for any costs or other charges related to such medical treatment. It is Student's and parent's or legal guardian's express intent that this release and hold harmless agreement shall bind the members of Student's family, if Student is alive, and Student's estate, family, heirs, administrators, personal representatives, or assigns, if Student is deceased, and shall be deemed as a "Release, Waiver, Discharge and Covenant" not to sue the above-named Releasees. Student and parent or legal guardian further agree to save and hold harmless, indemnify, and defend Releasees from any claim by Student or Student's family, arising out of participation in the EXALT! Youth Conference. In signing this Release, Student and parent or legal guardian acknowledge and represent that they have fully informed themselves of the content of the foregoing waiver of liability and hold harmless agreement by reading it before they sign it, and they understand that they are signing this document as the Student's own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written statement, have been made. Student and parent or legal guardian agree that Student is voluntarily participating in this activity, despite the possible dangers and risks and despite this Release. Student and parent or legal guardian agree to pay for any damages to Maritime Christian College or Canoe Cove Christian Camp facilities as determined by Maritime Christian College or Canoe Cove Christian Camp officials. I understand that neither MCC nor the Board of Trustees and its officers, agents, employees, and any student acting as employees will bear any liability or responsibility for property of the above named which is damaged, stolen, or lost during the event. Parent or legal guardian further state that he/she/they are the legal parent or guardian of Student and have legal authority to sign this agreement; and that Student and parent or legal guardian execute this release for full, adequate, and complete consideration fully intending to be bound by the same. Student and parent or legal guardian further state that there are no health-related reasons or problems which preclude or restrict Student's participation in this activity, and that Student has adequate health insurance necessary to provide for and pay any medical costs that may be attendant as a result of injury to Student. The parties further agree that this Release shall be construed in accordance with the laws of the Province of Prince Edward Island. If any term or provision of this Release shall be held illegal, unenforceable, or in conflict with any law governing this Release the validity of the remaining portions shall not be affected thereby.
